



## Pet Boarding and Doggy Daycare Policies and Release of Liability

**THIS AGREEMENT** is entered into by and between Red Rover Pet Boarding, LLC, (henceforth referred to as RRPB), and pet Owner:

1. I (Owner) represent that I am the legal owner of the above named pet(s) and I assume all risks, dangers, and responsibility for injuries to the named pet(s). Owner understands and agrees that Owner is solely responsible for any harm to Owner's pet(s) while pet(s) is /are attending Daycare/Boarding. \_\_\_\_\_
2. PHOTO AND VIDEO RELEASE: Owner agrees to allow RRPB to use Owner's pet's name and any images or likeness of Owner's pet taken while he/she is at RRPB, in any form, for use at any time, in any media, marketing, advertising, illustration, trade or promotional materials without compensation, and Owner release to RRPB all rights that Owner may possess or claim to such image, likeness, recording, etc. \_\_\_\_\_
3. PET'S HEALTH: Owner further understands and attests that Owner's pet(s) are healthy and will at all times while attending RRPB have current vaccinations for rabies, distemper, and Bordetella. Owner is not enrolling any pet that has any condition that could potentially jeopardize the health of other pets or people and has not had any potentially communicable condition within 30 days prior to enrollment. Owner further understands that even if Owner(s) pet is vaccinated for Bordetella (Kennel Cough) there is a chance that the Owner's pet can still contract Kennel Cough. Owner agrees that Owner will not hold RRPB responsible if Owner's pet(s) contracts Kennel Cough or other pet-pet transmitted ailments. Owner understands RRPB REQUIRE THE BORDETELLA VACCINE EVERY 6 MONTHS. RABIES AND DISTEMPER ARE ADMINISTERED AS PER STATE LAW AND VETERINARIAN RECOMMENDATION. \_\_\_\_\_
4. FLEA/TICK/LICE FREE: All pets must be flea/tick/lice free. Should a pet be observed to have fleas/ticks/lice, a flea/tick/lice bath treatment will be applied and charged to the owner at a rate of up to \$85.00 depending on severity of infestation, size of pet(s) and condition of haircoat of the pet(s). \_\_\_\_\_
5. GROUP PLAY: All pets must pass a general behavior assessment in order to attend pet-pet group play. No pet may be admitted to group play who shows any signs of any type of aggression. Owner further understands and agrees that in admitting Owner's pet(s) to pet-pet group play, Owner is representing to RRPB that Owner's pet(s) is/are in good health and have not harmed, shown aggression, or exhibited any threatening behavior towards any Person or other pets. Any pet demonstrating aggression or other behavior deemed unacceptable by RRPB staff may be required to leave daycare/boarding. \_\_\_\_\_
6. RELEASE OF LIABILITY: Owner understands and agrees that during normal pet play, Owner's pet may sustain injuries. Pet play is monitored by RRPB staff to best avoid injury, but scratches, punctures, torn ligaments, and other injuries may occur despite the best supervision. Owner further understand and agrees that neither RRPB nor any of its employees, owner, staff, or volunteers will be liable for any illness, injury, death, and/or escape of Owner's pet(s) provided that reasonable care and precautions are followed, and Owner hereby release RRPB staff, owners, or volunteers of any liability of any kind whatsoever arising from or as a result of Owner's pet(s) attending RRPB. \_\_\_\_\_
7. PERSONAL PROPERTY: Owner understands that Owner is solely responsible for any harm to the equipment, facilities, or any other property of RRPB, caused by Owners pet(s). Owner also agrees that RRPB shall not be responsible or liable for any lost or damaged personal property belonging either to Owner or Owner's pet. \_\_\_\_\_
8. FOOD/MEDS: When boarding overnight, Owner agrees that it is the Owner's responsibility to leave an adequate supply of food and medication for Owner's pet(s) during the entire time Owner's pet is cared for by

RRPB. Should the food/medication supply need replenishment, Owner authorizes RRPB to purchase replacement food/meds and Owner will reimburse RRPB for actual food/meds plus \$30.00 time /distance fee, or RRPB house food will be charged to Owner at a cost of \$2.50/feeding.\_\_\_\_\_

9. VETERINARIAN LIABILITY AND CARE: Owner authorizes RRPB to obtain medical treatment for Owner's pet(s) if he/she appears ill, injured, or exhibits any other behavior that would reasonably suggest that pet(s) may need medical treatment. Owner agrees to be fully responsible for the cost of such medical treatment and for the cost of any transportation for the purposes of such treatment. Owner gives permission to RRPB to use Clear Creek Veterinary or nearest available veterinarian for required treatment Yes\_\_\_\_\_ or No\_\_\_\_\_ If Yes, treatment must not exceed a maximum dollar amount of \$\_\_\_\_\_.
10. HIGH RISK PETS: Owner understands special-needs pets, puppies/kittens, and senior pets naturally have a higher risk of injury, stress-related illnesses, weakened immune system, or exacerbation of any pre-existing condition. As such, by using our facility for daycare or boarding, the Owner is waiving any claim for injury or illness experienced by the Owner's pet while in our care.\_\_\_\_\_
11. ELDERLY PETS: Owners of elderly pets (approaching the end of life) need to know if in the event Owner's pet passes on while in the care of RRPB, RRPB policy is to hold the pet in RRPB freezer until we reach the Owner for further instructions. By admitting their elderly pet for boarding/daycare, Owner waives any claim for injury or illness in the event of their pet's death while in the care of RRPB. \_\_\_\_\_
12. PAYMENTS: Drop In daycare and boarding payments are due at pickup. Bus daycare invoices must be paid within 30 days of Owner receiving the monthly invoice. We accept cash, local checks, and credit/debit cards. We do not hold cards on file.\_\_\_\_\_
13. CLOSING TIME: Owner acknowledges RRPB regularly scheduled business hours and understands Owner may not pick up or drop off pet(s) during closed hours. To be on RRPB/Kolar property during closed hours constitutes trespassing. \_\_\_\_\_
14. PERSONAL RISK: Owner and invitees of Owner acknowledge risks including but not limited to: ice, snow, tripping hazards, vehicle traffic, and/or slippery footing present on RRPB property and understand RRPB is not responsible for any claims made for injury sustained to Owner or their pet(s) while on Kolar/RRPB property. \_\_\_\_\_
15. RIGHT OF REFUSAL: RRPB reserves the right to refuse admittance to any pet or dismiss any pet that does not meet or maintain the health, temperament or other daycare/boarding standards. The determination shall be made at the sole discretion of RRPB.\_\_\_\_\_
16. FULL FORCE AND EFFECT: Owner further understands and expressly agrees that each and every of the foregoing provisions contained in paragraphs 1-16 shall be in force and effect and shall apply to each and every occasion on which Owner's pet (s) stays with RRPB for daycare, boarding, or other services, as the case may be. This Agreement shall remain in full force and effect as between the parties until and unless otherwise canceled or superseded by a written agreement signed by the parties.\_\_\_\_\_
